The Caswell Center Foundation, Inc. will provide up to three \$1,000 academic scholarships for the 2012-2013 academic year to qualified applicants. Applicants must be a rising college senior or working on their graduate degree within Allied Health, Education or Psychology fields: Occupational Therapy, Recreation Therapy, Special Education, Nursing, Speech-Language Pathology or Social Work with the intent of serving persons with intellectual and developmental disabilities. The 2012-2013 scholarships will be available to individuals residing in one of the following 38 counties: Beaufort, Bertie, Bladen, Brunswick, Camden, Carteret, Chowan, Columbus, Craven, Cumberland, Currituck, Dare, Duplin, Edgecombe, Gates, Greene, Hertford, Hyde, Johnston, Jones, Lenoir, Martin, Nash, New Hanover, Northampton, Onslow, Pamlico, Pasquotank, Pender, Perquimans, Pitt, Robeson, Sampson, Scotland, Tyrrell, Washington, Wayne or Wilson.

A rising college senior or graduate student must meet the following eligibility criteria to apply for his/her respective scholarship:

- Be a full-time college student or graduate student.
- Have a cumulative grade point average of 2.5 or higher, or a graduate cumulative grade point average of 3.0 or higher.
- Continue to major in one of the degree programs cited above.
- Demonstrate evidence of volunteer (or paid) experience.

The student must also submit the following to apply for the scholarship:

- Caswell Center Foundation Scholarship Application Form.
- Graduate school acceptance letter if applicable.
- Recommendation letters from volunteer experience or previous contribution to the field.
- At least one letter of reference from a professor.
- OFFICIAL Transcript.
